# **Stallion Reports**

When registering a foal, a pedigree for the foal can only be established on the Sire and/or Dam if a Stallion Breeding Report is on file with the office of the AApA, Inc. and a valid Breeders Certificate is attached to

the application for registration of the foal(s) and a complete Parentage verification has been established to the Sire and/or Dam.

All mares bred during the breeding season (regardless of breed type) should be reported on this Report.

If these mares are registered with another approved breed registry than the AApA, need a copy of their registration papers and a 4 generation pedigree should accompany the Breeding Report, also their respective DNA case # and owners Authorization for AApA use, with a one time \$30.- filing fee for DNA to the AApA DNA database.

Appaloosa stallions registered other than AApA, Inc. bred to an AApA, Inc. registered mare must file a Stallion Breeding Report with the office of the AApA, Inc. with a copy of the stallion's registration certificate (front and back) attached to the Breeding Report and a 4 generation pedigree of the stallion and a copy of the stallion's DNA Case# or DNA report of his respective registry. An owner Authorization for the AApA, Inc. to obtain the DNA from the other registry plus a one time \$30.- filling fee for the DNA to the AApA DNA database.

There is NO filing fee for Appaloosa Stallion Breeding Reports (Active AApA members only / \$15 is non-member!)

Stallions other than Appaloosas (recognized breed Associations AQHA, AHA, J.C. only) must also file a Breeding Report with the AApA, Inc. at the end of the breeding season. A copy of the stallion's registration papers with a 4 generation pedigree, a copy of his DNA case # or DNA Report, owners Authorization for the AApA to use the DNA, plus a one time \$30.- filing fee for the DNA to the AApA DNA database. Annual Stallion Report filing fee (members) \$25.- or (non-members) \$45.- . If you wish to permanently identify your stallion as Breeding stock with the AApA to receive the filing rate of \$25.- (annually), please send a copy of his reg. papers, proof of ownership, two full pictures of the horse, his DNA case #, DNA use authorization plus \$30.- filing fee of DNA to the AApA database, and \$45.- Identification set up charge with your request. (Stallions can not display large Bald face (including eye(s), oversized stockings (up to but not including the knee(s) / hock(s), and no other paint markings. Double Registered Paint / AQHA stallions are not able to be identified with the AApA.

A copy of the HYPP test is required with the filing of the Stallion's Breeding Report, should the stallion trace back to the American Quarter horse "Impressive". If no HYPP test is available, the resulting foal(s) MUST be Tested before a registration certificate can be issued. (HYPP N/N only)!

### **DNA requirements:**

All Breeding Stallions and Mares MUST have a DNA on file with the office of the AApA, Inc. before any foals can

<u>be registered.</u> (Stallions foaled 1990 and before do not have to be tested, but the owner has the option to do so, some blood type tests have the possibility of conversion to DNA. Contact our office)

Stallions that already have a DNA on file with another Registry / Laboratory than the University of California-Davis should send a copy of their DNA record or case# to the registration Dept of the AApA, Inc. plus \$30.00 - filing fee for filing the DNA with the AApA DNA database.

AApA Stallion owners, if your stallion has been DNA tested, you need not to do anything, and we have your horses DNA on file.
